

END-USER LICENSE AGREEMENT FOR TRANSITION PACK 1 IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL:

FilmImpact.net End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and FilmImpact.net. for the FilmImpact.net software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("Transition Pack 1").

By installing, copying, or otherwise using the Transition Pack 1, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and FilmImpact.net, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the Transition Pack 1. #### 1. GRANT OF LICENSE.
